

Traffic Amnesty Program

You might be eligible for a *50% or 80% reduction* depending on income and have your driver's license reinstated.

To qualify for 50% or 80% reduction of the amount owed, all of the following conditions must be met:

- ✓ You have an outstanding traffic case that was due to be paid on or before January 1, 2013.
- ✓ The last day you made a payment was on or before September 30, 2015.
- ✓ Persons who made a payment after September 30, 2015 on a ticket are not eligible for a reduction for that ticket, but may be eligible to have their driver's license reinstated if they are in good standing and are on a current pay plan with a comprehensive collection program.
- ✓ You don't owe victim restitution to a victim on any case in the county where the traffic case was filed.
- ✓ You have no outstanding warrants in the county where the traffic case was filed.
