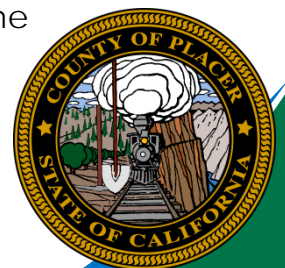
Local Government:
