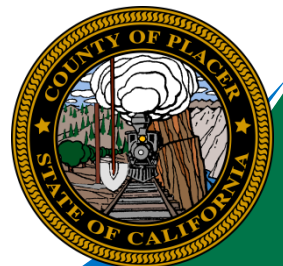
Reports: Local Government:

A. Establishment of Asian Citrus Psyllid Quarantine in Western Placer County -Josh Huntsinger, Placer County Agricultural Commissioner-

Provided information on the discovery of the Asian Citrus Psyllid in Placer County, the areas of the County currently under quarantine, as well as the steps that are being taken to increase awareness and aid in detection. He also provided a brief overview of the County's Cannabis ordinances.

B. Community Development Resource Agency Overview-Steve Pedretti, Director CDRA-

Provided an overview of the roles that CDRA plays in county development, as well as gave an update on the business plan for the year including the goals that CDRA wishes to meet and how they plan to do so.

C. Secondary Dwelling ZTA- Emily Setzer, Planning Services Division

Presented information on a proposed secondary dwelling zoning text amendment meant to bring the county into compliance with state law and to create a new county ordinance for this purpose.
