ROGERS VARIANCE (PVAA 20120154)

APPEAL OF THE ZONING ADMINISTRATORS DENIAL OF A VARIANCE CATEGORICAL EXEMPTION

SUPERVISORIAL DISTRICT 3 (HOLMES)

(APPELLANT IS REQUESTING A CONTINUANCE TO NEXT AVAILABLE DATE)

Consider an Appeal from the property owner, Daryl Rogers, of the Zoning Administrator's denial of a Variance to allow for 1) construction of an approximately 396 square foot shed one foot from the east side property line (where 30 feet is normally required), 2) construction of an approximately 420 square foot barn eight feet from the east side property line (where 30 feet is normally required), 3) placement of an animal enclosure zero feet from the east property line (where 30 feet is normally required), and 4) placement of an animal enclosure closer to the common property line (east), than the distance from the property line to the adjacent residence (Zoning Ordinance Section 17.56.020(c)(1) (Accessory Buildings and Uses - Animal Enclosures). The Planning Commission will also consider a finding of Categorical Exemption [Section 15303 of the CEQA Guidelines and Section 18.36.050 of the Placer County Environmental Review Ordinance (Class 3 – New Construction or Conversion of Small Structures)].
