

## HELPING OUR COMMUNITY GET BACK TO WORK

Placer County's *Help to HIRE* program reimburses employers up to **\$10,500** over 6 months for hiring eligible participants in Placer County's Employment Services Program.

**100%** wage reimbursement is available for the first 30 days!

The remaining 5 months wages are reimbursed at a flat rate not to exceed actual wages:

- **\$1,500** per month for 40 hours a week
- **\$1,000** per month for 30-39 hours per week
- **\$500** per month for 20-29 hours per week

# Help to HIRE

## Placer County's Subsidized Wage Program

### Benefits Include:

- **Up to \$10,500** for each eligible hire.
- **100% Reimbursement** of wages for first 30 days, up to \$3,000.
- **No Limit** to the number of new hires.
- **Prompt reimbursement** of wages for up to 6 months.
- **Pre-screened applicants** that fit your specific qualifications and needs.
- **Ongoing support** to ensure retention.
- **Possible tax incentives.**
- **Free advertisement** of current job openings.

Placer County's Employment Services Program provides reimbursement to employers for wages paid to eligible new hires through the *Help to HIRE* program.

### Eligible Candidates:

- Placer County residents
- Enrolled in Placer County's Employment Program
- Not related to any company administrator



### Expectations For Employers

- \* Participants are employees of your company.
- \* Hired participants may not displace any present employees from regular work hours, wages, or benefits.
- \* Participants must be offered equivalent wages & benefits afforded other employees.
- \* Compensation at minimum wage or above
- \* Screen, interview, & select new hires through your regular hiring process.
- \* Employers may not have had layoffs within the last 120 days.
- \* Monthly invoices must be submitted timely in order to receive prompt reimbursement.
