BACKGROUND/COMMUNITY BENEFITS: In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked once again to approve appropriations to help raise funds designated for childhood cancer research. St. Baldrick's began as a casual conversation between friends and has exploded into the world's biggest volunteer-driven fundraising program for childhood cancer! Events have taken place in 18 countries and 46 US states, raising over \$34 million, and shaving more than 46,000 heads. Each year 160,000 children are diagnosed worldwide and despite tremendous progress, events like these are important to help find a cure. The Keaton Raphael Memorial charity in conjunction with the St Baldrick's Foundation coordinates this local St. Patrick's Day national head shaving event. This year's event takes place on March 14 at the Westfield Galleria. Again, the funds designated towards this popular event benefit childhood cancer research.
