ACTION REQUESTED

BACKGROUND

Candi began her career in 1985 with the Placer County Auditor-Controller’s Office where she worked as a part time Account Clerk II, and she became a full time employee nine months later. Her hard work and dedication were quickly recognized at the Auditor-Controller’s Office as she was promoted through the ranks to Accountant-Auditor II before transferring to the Administrative Services Department in 1996. Candi’s combined leadership and accounting skills made her the logical choice to be promoted to Administrative Services Officer in 1999.
