#### A. Development of Countywide parks and Trails Master Plan

County Staff will provide the MAC with an introduction and overview on the County's preparation of a new Countywide Parks and Trails Master Plan.

#### B. Hidden Falls Regional Park Trails Expansion Project

Placer County is the Lead Agency for the Hidden Falls Regional Park Trails Network Expansion Project, and is preparing a Subsequent Environmental Impact Report (SEIR) for the Hidden Falls Regional Park Trails Network Expansion Project. Hidden Falls Regional Park currently includes approximately 30 miles of trails that are open to the public. The proposed project would expand the trail system into areas north and east of the existing park, where the County holds existing trail easements. In total, approximately 30 additional miles of trails would be added, along with the construction of three additional bridges over Coon Creek, additional parking and access areas and improvements, and possible improvement of off-site access roads.

#### 9. Action Items:

#### A. La Faille Ranch Vesting Tentative Map (PSUB 20110084)

The La Faille Ranch Vesting Tentative Map consists of a 14-unit Major Subdivision on an approximately 172-acre property located in the Penryn area. The property is zoned F-B-X 10 AC. MIN. (Farm, combining Building Site designation of 10-acreminimum parcel size) and has a Placer County General Plan designation of Agriculture/Timberland, 10-acre minimum. The proposed parcels would range in size from approximately 10-15 acres. The project site is located on hilly terrain east of the City of Lincoln. State Route 193 roughly marks the northern boundary of the property and a cement-lined reach of the Caperton Canal roughly marks the southern boundary of the project site. Access to the site would be from a private road extending south/ southeast from State Route 193. Subdivision improvements will include a private gated entry with an approximate 4,000 foot road provided to each lot.

It is anticipated that site development will involve partial clearing and grading of the site, trenching and digging for underground utilities and infrastructure, and ultimately the construction of new roadways, trails/pathways, driveways, buildings, and landscaping. The application requires the approval of Vesting Tentative Subdivision Map. County staff will request the MAC take action to provide a recommendation on the Vesting Tentative Subdivision Map to the Planning Commission.
